12.3Bioaccumulative potential

An estimated BCF of 3 was calculated in fish for picryl sulfonic acid(SRC), using an estimated log Kow of -1.71(1) and a regression-derived equation(2). According to a classification scheme(3), this BCF suggests the potential for bioconcentration in aquatic organisms is low(SRC).

12.4Mobility in soil

Using a structure estimation method based on molecular connectivity indices(1), the Koc of picryl sulfonic acid can be estimated to be 120(SRC). According to a classification scheme(2), this estimated Koc value suggests that picryl sulfonic acid is expected to have high mobility in soil. The pKa of picryl sulfonic acid is estimated as 0.31(3), indicating that this compound will exist entirely in anion form in the environment and anions generally do not adsorb more strongly to soils containing organic carbon and clay than their neutral counterparts(4).

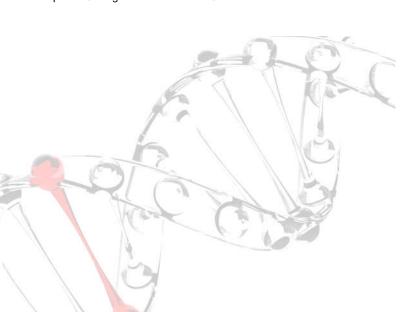
