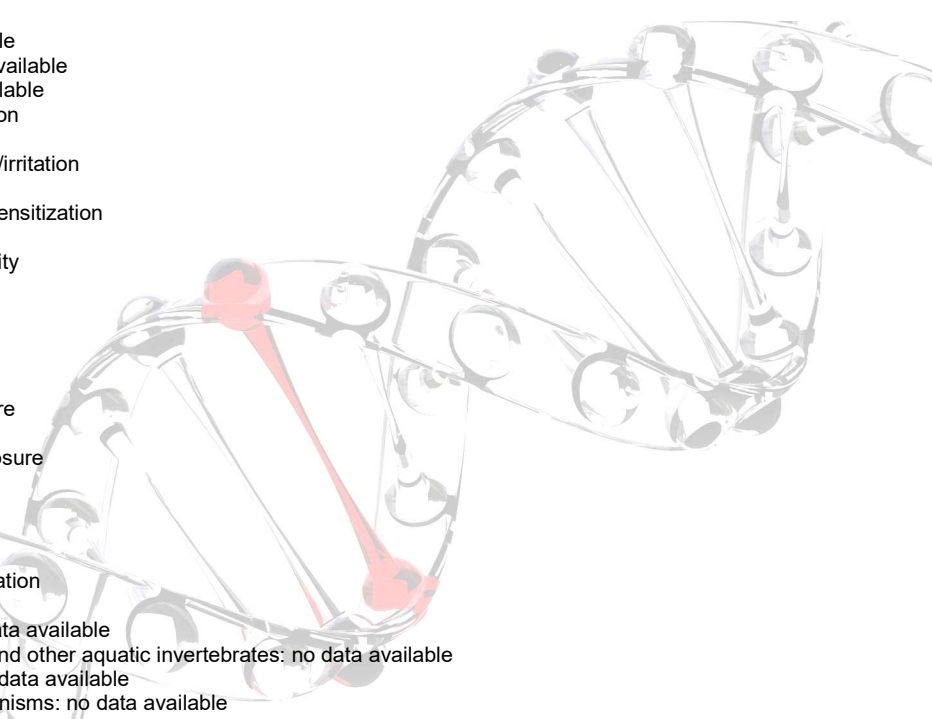
Contaminated packaging
