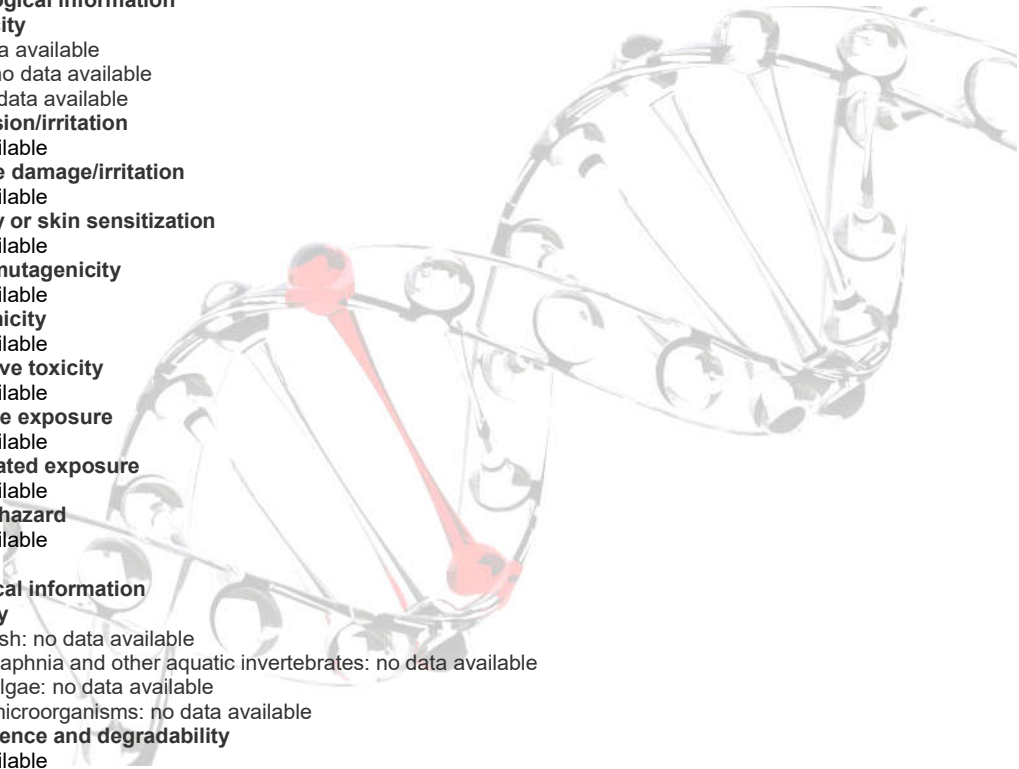
Contaminated packaging
